Orders must be prepaid with a single payment and must be received by our offices at least 5 business days prior to your visit. Orders will be shipped via FedEx 2-Day to physical addresses only. A signature is required for delivery. Orders with P.O. Box addresses will not be processed. (A \$15 charge will apply if you request overnight delivery.)

Additional group tickets may be purchased on the day of your visit at the regular group rate, which is \$21.50 for general admission (ages 12 and up) and \$17.99 for children (ages 3-11) plus tax, with a copy of your invoice. If you do not have a copy of your invoice at the gate, you will not be able to purchase additional tickets at the regular group rate. Refunds will be issued by mail for any unused tickets beyond the minimum order of (5) one-day tickets.
